This frame shows Nano Nagle, the foundress of the community of Presentation Sisters in Cork, Ireland, in 1775. Nano became known as “The Lady of the Lantern” because she would take her lantern through the city lanes and alleyways where she visited the sick and dying. The ribbon of light shining from her lantern flows through every frame of the entire stained glass project as a sign of her blessing on all future missions.*
